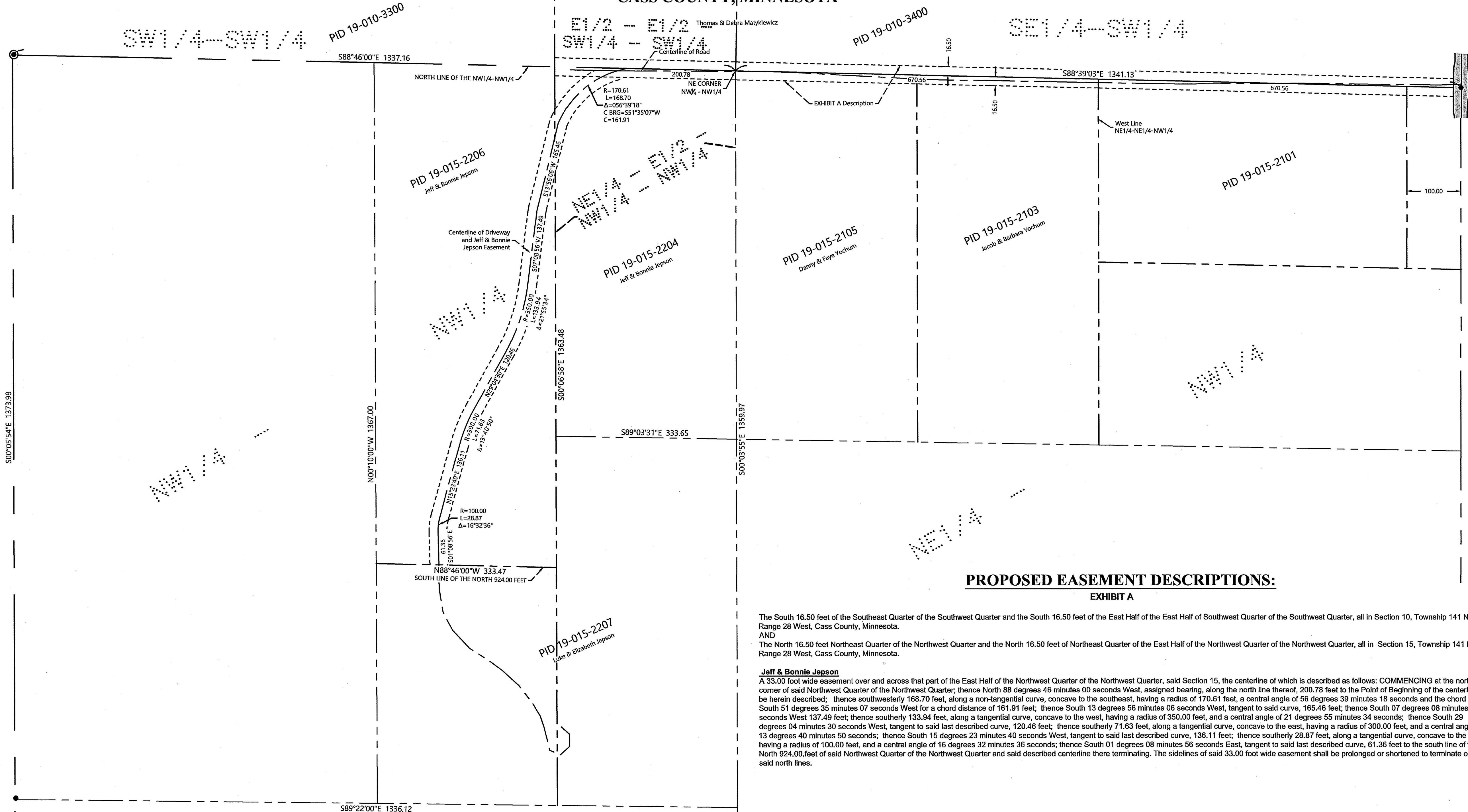


CERTIFICATE OF SURVEY

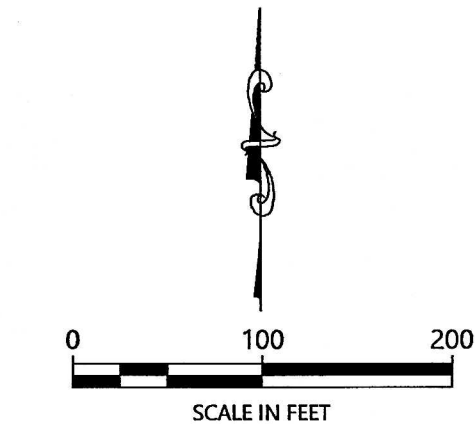
PART OF THE NORTH HALF OF THE NORTHWEST QUARTER, SECTION 15,

PROPOSED EASEMENT DESCRIPTIONS:

The South 16.50 feet of the Southeast Quarter of the Southwest Quarter and the South 16.50 feet of the East Half of the East Half of Southwest Quarter of the Southwest Quarter, all in Section 10, Township 141 North, Range 28 West, Cass County, Minnesota.
AND
The North 16.50 feet Northeast Quarter of the Northwest Quarter and the North 16.50 feet of Northeast Quarter of the East Half of the Northwest Quarter of the Northwest Quarter, all in Section 15, Township 141 North, Range 28 West, Cass County, Minnesota.

Jeff & Bonnie Jepson
A 33.00 foot wide easement over and across that part of the East Half of the Northwest Quarter of the Northwest Quarter, said Section 15, the centerline of which is described as follows: COMMENCING at the northeast corner of said Northwest Quarter of the Northwest Quarter; thence North 88 degrees 46 minutes 00 seconds West, assigned bearing, along the north line thereof, 200.78 feet to the Point of Beginning of the centerline to be herein described; thence southwesterly 168.70 feet, along a non-tangential curve, concave to the southeast, having a radius of 170.61 feet, a central angle of 56 degrees 39 minutes 18 seconds and the chord bears South 51 degrees 35 minutes 07 seconds West for a chord distance of 161.91 feet; thence South 13 degrees 56 minutes 06 seconds West, tangent to said curve, 165.46 feet; thence South 07 degrees 08 minutes 56 seconds West 137.49 feet; thence southerly 133.94 feet, along a tangential curve, concave to the west, having a radius of 350.00 feet, and a central angle of 21 degrees 55 minutes 34 seconds, thence South 29 degrees 04 minutes 30 seconds West, tangent to said last described curve, 120.46 feet; thence southerly 71.63 feet, along a tangential curve, concave to the east, having a radius of 300.00 feet, and a central angle of 13 degrees 40 minutes 50 seconds; thence South 15 degrees 23 minutes 40 seconds West, tangent to said last described curve, 136.11 feet; thence southerly 28.87 feet, along a tangential curve, concave to the east, having a radius of 100.00 feet, and a central angle of 16 degrees 32 minutes 36 seconds; thence South 01 degrees 08 minutes 56 seconds East, tangent to said last described curve, 61.36 feet to the south line of the North 924.00 feet of said Northwest Quarter of the Northwest Quarter and said described centerline there terminating. The sidelines of said 33.00 foot wide easement shall be prolonged or shortened to terminate on said north lines.
