County of Cass, State of Minnesota


At the corner location shown on the sketch:

**STATEMENT OF EVIDENCE:**

NORTHEAST CORNER SECTION 20,  
TOWNSHIP 140 NORTH, RANGE 30 WEST,  
CASS COUNTY, MINNESOTA

- 1865** The original public land survey was completed under George Wright and Thomas Walker and a wood post was set to mark the corner along with the following bearing ties.

- 1907** John Curo found the bearing tree northwest and BT stump northeast of the old government bearing trees and set a Pine Post at the corner location.(Cass Svy Book B, Page 433-431).
- 1918** E.B. Horst found the stake and set a 2" dia by 48" iron monument at the corner and 19.8 feet north as a witness corner.(Cass Svy Book C Page 105, Rec #397)
- 1921** E.B. Horst finds the corner pipe and witness corner pipe in place during a resurvey of Section 17. (Cass Svy Book C, P440-442, Rec # 464)
- 1959** A highway plan set by the Minnesota Dept of Highways indicates a corner approximately 352.5 feet southerly of the highway centerline at station 74+28. (S.P. 11-605-01)
- 2000** A Cass County crew visited the corner and found a 2" diameter down 0.5 feet near the centerline of a North-South gravel township road. (Cass Proj. 98-008)

- 2024** A Cass County survey crew found a 2 inch I.D iron pipe down 1.8 feet and set a 1/2" diameter 18" long pipe over it with a 1-1/2" diameter stamped aluminum cap. (Proj 2022-045)
