

- April 1858 E.N. Darling GLO Deputy Surveyor set a wood post for the original corner and referenced it as follows:

| 20" Pine | S30°W | 37 links (24.42 feet) |
- April 1905 Town road survey of the Pillager and Pine River Road, Cass County Road Calendar Book, Page 42, on file at the CCSO (No mention of corner).
- April 1911 A.W. Moulster, County Survey Record Book "A" Page 465-472, set a 5/8" x 36" iron. (also on micro film roll 105 bk 49 P58, P64).
- Nov. 2005 K.L.D. Surveying of Brainerd found and used an iron at the South 1/4 corner for a survey in Section 33, (Survey on file at the CCSO).
- Nov. 2010 Craig E. Johnson, LS, CFedS, found a 5/8"x5/8" square iron spike the iron matched the position of the K.L.D. survey. The pipe was accepted as the corner and reference ties set as depicted on the face of this certificate.
