



Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minn., and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 21st day of January, 1964, I found the center North 1/16 corner of Section 21 which was evidenced by a monument set by the GLO survey of 1918 which is a 1 inch diameter iron post with a brass cap stamped

The bearing trees for this corner were not found.
