



WILLIAM H. OKERMAN , being first duly sworn, deposes and says:
That I reside at Bemidji Minnesota , and am registered as a Land Surveyor under the
laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807
I further depose and say that on the 26th day of September , 19 63 ,
I found the Section corner of Sections 13-14-23-24
which was evidenced by the remains of a survey by the U. S. Government in 1914.
N Pine 20" N36⁰ E 117 lks (77.2') found white pine with scribing visible at record
bearing and distance.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker
consisting of a 6" diameter 24" long cylindrical concrete monument flush with ground and
capped with a 3" diameter bronze tablet stamped:
