



WILLIAM H. OKERMAN, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 30th day of June, 1964, I found the Section corner of Sections 30-31-25-26 36 which was evidenced by remains of original government survey of 1872.

W Pine 14" S20°E 7 lks 4.62' (now a decayed stump at record bearing and distance).

Birch 12" S58°W 12 lks - 7.92' (now a decayed stump at record bearing and distance).

Also squared wood post at corner location.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 60" long galvanized steel monument filled with concrete,

and capped with a 3-inch diameter bronze tablet stamped:
