




..... William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 19th day of September, 19 63, I found the Section corner of Sections 1-2-35-36 which was evidenced by an iron pipe 1½" diameter set by J. A. Gjelhaug, Civil Engineer.

Balm of Gilead 8" N2½ E 86 links (Now a 15" Balm of Gilead N2½ E 57.0 feet scribe marks visible)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 60" long galvanized steel monument capped with a 3" diameter bronze tablet stamped:-
