That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 15th day of June, 1964, I found the Section corner of Sections 34-35-2-3 which was evidenced by remains of a survey by Cass County Surveyor James H. Flynn in 1922. Iron pipe (found in intersection of road)

"Notes of Cass County Surveyor Harold Curo in 1951".

Oak 5" N14°30'W 79.25' (Now a 8" Oak at record bearing and distance)

Spruce 10" N77°12'E 140.5' (Now a 15" Spruce at record bearing and distance)
