

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 6th day of October, 1966, I found the Witness corner of section 7 which was evidenced by remains of the G.L.O. resurvey of 1919. Corner was found to be

marked by a 1 inch diameter iron pipe with brass cap stamped
