



William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 27th day of November, 1964, I found the Quarter corner of Section's 15 & 16, which was evidenced by remains of G.L.O. resurvey of 1917.

Cedar 5 inch N15½° E 58.08 feet - now a decayed stump.
Poplar 5 inch S57 ¾ W 15.18 feet - not found.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new marker set. Old one in good condition.
