

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 16th day of April, 1962, I found the Center East 1/16 corner of Section 15 which was evidenced by the remains of the G.L.O. survey of 1917.

Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:

Red Oak 6 inch S32 $\frac{1}{4}$ °E 170 links (112.20') (now a 13 inch oak at record bearing and distance with scribe overgrown.)  
 Poplar 14 inch S44 $\frac{1}{4}$ °W 184 links (121.44') (now a stump hole at record bearing and distance)

C  $\frac{E\ 1/16}{S\ 15}$  C  
 1917

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Jack pine 9 inch N25°E 67.4 feet Marked C E 1/16 15 BT

Oak 13 inch S32 $\frac{1}{4}$ °E 112.2 feet re-marked BT

Steel sign post 72 inches long, set 24 inches in ground with standard signs 54-2 and 54-4 attached due West 3.4 feet.

All reference bearings are true bearings.
