

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 5th day of October, 1964, I found the E 1/16 corner of Section's 19 - 30 which was evidenced by a 2 inch diameter iron monument. Notes are on record in the Cass County Courthouse..

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 foot long galvanized steel monument filled with concrete and capped with a 3 inch diameter bronze tablet stamped:

T141N, R30W
E 1/16 S19
S30
1965

from which reference or witness monuments are located in the manner following: R.L.S. No. 6807

Tamarack 3 inch N75°W 114.5 feet scribed x BT.
Oak 10 inch S80°E 95.0 feet scribed E 1/16 S30 BT.

Steel sign post 72 inches long set 24 inches in ground with Forest Service signs 54-4 and 54-2 attached due North 15.7 feet.
