

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 5th day of October, 1964, I found the section corner of sections 19-20-29-30 which was evidenced by 2 inch diameter iron post, County survey.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 feet long galvanized iron post filled with concrete and capped with a 3 inch diameter bronze tablet stamped.
