

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Meander Corner

Corner to Sec's 5-8 T. 111 N. R. 31W No. 92

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 26th day of September, 1962, I found the Meander Corner corner of Sections 5-8 which was evidenced by one remaining bearing tree from the original government survey of 1873.

Birch 8" N81°E 85 Lks. or 56.1 feet (Now a 1 1/2" birch stub 6 feet high with blaze window facing corner N81°E 56.1 feet.)

Corner was found to be marked by a 2" x 1/8" iron pipe set by Cass County Surveyor E. B. Horst in 1917.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter, 5 foot long galvanized wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped:

T111N R31W

S 8

from which reference or witness monuments are located in the manner following:
