

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 20th day of July, 1962, I found the Southwest 1/16 corner of Section 30 which was evidenced by 1-3/4" diameter iron pipe set by Cass County Surveyor E. B. Horst in 1921. Notes of his survey were found in Cass County record book "C" page 447.

Pipe was found alongside a fence corner estimated to be 30 years old.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 5' long galvanized wrought iron pipe filled with concrete and capped with a 3" diameter bronze tablet stamped:-

 SW 1/16 S 30  
 1962  
 RLS No. 3628

from which reference or witness monuments are located in the manner following:

Jack pine 5" S66½°E 19.5' MKD "X" BT

Jack pine 9" N64°W 61.3' MKD SW 1/16 BT

All reference bearings are true bearings.
