

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 25th day of April, 1962, I found the Meander corner of Sections 26 - 35 which was evidenced by a survey of Cass County Surveyor E. B. Horst in 1920 recorded in County Record book C page 462.

 Location checks with aerial photos and cleared property line.
