

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 27th day of July, 1962, I found the Std. Quarter corner of Section 31 which was evidenced by Notes and plat of Cass County Surveyor E. P. Horst in 1921.

Iron monument (Found a 1-3/4" diameter iron pipe marking corner).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 5' long galvanized wrought iron pipe filled with concrete and capped with a 3" diameter bronze tablet stamped:-
