

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.
 I further depose and say that on the 30th day of July, 1962, I found the Standard corner of Sections 31 - 32 which was evidenced by Notes and Plat of Cass County Surveyor E.P. Horst in 1921. Corner re-established from original bearing trees. Iron monument (found a 1-3/4" diameter iron pipe marking corner)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 5' long galvanized wrought iron pipe filled with concrete and capped with a 3" diameter bronze tablet stamped:-
