





William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 3rd day of December, 1965, I found the West 1/16 corner of Section 6 - 31 which was evidenced by remains of the G.L.O. resurvey of 1924

Maple 10" N37°E 40 Links (Now a 16" N37°E 26.40' scribe overgrown)

Birch 6" S54°W 17 Links (Now a 14" S54°W 11.22' scribe visible)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.
