That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 30th day of June, 1966, I found the Quarter corner of Sections 20-21 which was evidenced by G.L.O. resurvey of 1937

a set iron post 3 feet long 1 inch in diameter with brass cap marked

Poplar 7 inch N87 $\frac{1}{2}$ °E 36 links or 23.76 feet - Now a 17 inch Poplar at correct bearing and distance - scribe overgrown.
