, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 11th day of November, 1964, I found the Quarter corner of sections 29 and 32

which was evidenced by remains of the original Government survey of 1872

Cedar 12" S90°E 5 links (3.3') found decayed stump at record bearing and distance

Cedar 14" N28°W 15 links (9.9') found decayed stump at record bearing and distance

Found squared scribed post marking corner (possible original) also a 1" iron pipe

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 6" diameter, 60 inches long cylindrical concrete monument with a 3" diameter bronze tablet stamped:
