That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 21st day of August, 1963, I found the Center North 1/16 corner of Section 36 which was evidenced by an iron post 3' long, 1" diameter from the G. L. O. resurvey of 1930, with a brass cap marked:
