Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 1st day of December, 1961, I found the quarter corner of sections 1 - 12

which was evidenced by notes of the G.L.O. resurvey of 1927, which say: - point for corner is marked by a decayed wooden stake, in place of stake set iron post 1" dia., 3' long with brass cap marked $\frac{1}{4}$ S 1 from which are remains of the original BT's:-
S 12
1927

Tam. 18" fallen and dead S13°E 22 links or 14.52' with scribe plain (now a stump S7°E 14.5')

Tam. stp. 12" N15°W 14 links or 9.24' (now a stump N18°W 9.3')
Set cedar post 8"x5"x5" alongside iron post (found leaning west from iron post)
and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new marker set as iron post with brass cap is in place.



