

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 11th day of December, 1961, I found the Northwest 1/16 corner of Section 11 which was evidenced by remains of the G.L.O. survey of 1926, notes of this survey are on file in the Minnesota state capitol, St. Paul, Minnesota.

White pine 18" S38°W 29.6 feet marked S 11 BT





