







William H. Okerman, being first duly sworn, deposes and says:  
 That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807  
 I further depose and say that on the 1st day of December, 1961, I found the Angle Point #3 corner of Section 12 at adjusted position of original meander line, which was evidenced by a 1 inch diameter iron post with a brass cap marked:-

T144N / AP3 Set by G.L.O. in 1926  
 R29W |  
 S12 |  
 1926

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. brass cap is in good condition.
