





That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 9th day of May, 1966, I found the Quarter corner of Sections 2-11 which was evidenced by G.L.O. resurvey in 1933

a set iron post 3 feet by 1 inch in diameter with brass cap marked

Jack Pine 8 inch N31°E 138 lks or 91.08 feet - Now a 15 inch N31°E 91.08 feet - scribe overgrown.
