Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 7th day of March, 1963, I found the Quarter corner of Sections 13 - 14 which was evidenced by the remains of the G.L.O. resurvey of 1926.

Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:— $\frac{1}{4}$
