





William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 2nd day of May, 1966, I found the Quarter corner of Sections 13-24 which was evidenced by remains of G.L.O. resurvey of 1933

a 1 inch diameter iron post 3 feet long with brass cap marked $\frac{1}{4} \frac{S13}{S24}$

or
 Spruce 10 inch N74°W 12 lks / 7.92 feet (Now a 15 inch N74°W 7.92 feet) scribe overgrown.

or
 N. Pine 8 inch S21 3/4°W 18 lks / 11.88 feet (Now a 13 inch S21°W 11.88 feet) scribe overgrown.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new marker set, used G.L.O. brass cap

from which reference or witness monuments are located in the manner following:

G.L.O. N. Pine 13 inch S21°W 11.88 feet (rescribed 1/4S24BT)

Red Pine 10 inch N19°W 35.6 feet (scribed 1/4S13BT)

All reference bearings are true bearings.
