Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 16th day of January, 1962, I found the West 1/16 corner of Sections 24, 25 which was evidenced by an iron post with brass cap, post is 3 feet long, 1 inch dia. Cap is marked:

From which bears:

Burr Oak 5" N38 3/4° E 92Lks or 60.72' (now 8" oak N38 3/4° E 60.72' with blaze facing corner.)

Norway pine 10" S59 3/4° W 340 links or 224.40' (now in cleared area.)

The iron post with brass cap was set by G.L.O. resurvey in 1933.

The survey notes are on file in the state capitol St. Paul, Minnesota.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new marked set, used G.L.O. brass cap for the corner.
