That I reside at Bendiji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 3rd day of April, 1964, I found the Quarter corner of Sections 26 - 35 which was evidenced by G.L.O. resurvey of 1933

a set 1 inch diameter by 3 foot iron pipe with brass cap marked:
