







AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 2nd day of August, 1958, I found the 1/4 corner of sections 4-9

which was evidenced by one remaining original scribed bearing tree of the Government Survey of 1873.

(a) 10 inch Red Pine (now 26 inch with scribing 1/4-S visible) S. 60° E., 65 links or 42.9 feet.

I checked and found no evidence of original Government corner or other original Government bearing trees.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 foot long galvanized wrought iron pipe, filled with concrete and capped with a 3 inch diameter bronze stamped tablet:
