Peter J. Meyer, being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.
 I further depose and say that on the 5th day of November, 1958, I found the section corner of sections 11-12-13-14 which was evidenced by one remaining original scribed bearing tree of the Government Survey of 1874.

(a) 7 inch Jack Pine (now 18 inch stub with scribing 145 N-R visible) S. 41° W., 86 links or 56.8 feet.

I checked and found no evidence of the original Government corner or other original Government bearing trees.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter, 5 foot long galvanized wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped:

 R.L.S. 3628

All reference bearings are true bearings.


