That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 5th day of November, 1965, I found the Sta. Corner corner of Sections 36 - 31 which was evidenced by remains of G.L.O. resurvey of 1930.

Norway Pine N78°W 19.80 feet - Now a pine stump at record bearing and distance.

Oak 4 inch N18°E 22.44 feet - Now a 9 inch Oak at record bearing and distance - scribe visible.
