




Statement of Evidence

G-17, East Quarter corner of Section 10, Township 136 North, Range 31 West, 5th Principal Meridian.

Sept. R.Cronk, General Land Office (GLO) Deputy Surveyor, in the notes of the subdivision of Township 136
1870 North, Range 31 West, set a post for the original corner and referenced it as follows:
6" White Birch S 48-3/4°W 4 links 5" White Birch N 14-1/2° E 16 links

Said records are on file with the Minnesota Historical Society, St. Paul, Minnesota, copies are filed with the Cass County Surveyor's Office (CCSO).

Jan
2016 Ross Wamre, RLS 45334 set a ½ inch Rebar at a lost position. A Certificate of Location of Government Corner is on file in the office of the Cass County Recorder, filed as document number A000620050.

Nov.
2020 Lakes Area Surveying (LAS) searched for all previous evidence, finding no original evidence. The 2015 Wamre monument was not found. Because LAS had found a different monument at the southeast corner of Section 10 than the 2016 Wamre Survey, a different position was established. LAS established this corner based on a lost position between the Northeast Corner of Section 10 and the Southeast Corner of Section 10. Analysis of the recovered record data, field evidence and survey measurements, indicates that the monument set in November of 2020 by LAS is the accepted location of this corner
