


CERTIFICATE OF SURVEY



SURVEYOR'S NOTES:

- Bearing Orientation: The southwesterly line of Lot 6 of First Addition to Birchwood Terrace is assumed to have a bearing of North 58 degrees 02 minutes 37 seconds West.
- Vertical elevation and datum based on DNR lake benchmark on headwall of box culvert. Elevation = 1310.62 feet (NGVD29).
- The field survey was completed on 10/09/2024.
- Arro Land Surveying of Brainerd, INC. has made no investigation or independent search for easements of record, encumbrances, restrictive covenants, ownership title evidence, or any other facts that an accurate and current title search may disclose.
- It was verified that there are no wetlands present on the site by Mitch Brinks, Certified Wetland Delineator, #1007, on October 28, 20204

CERTIFICATE OF SURVEY

EXISTING DESCRIPTION –(Parcel No.: 42–008–2430)
