





PROPERTY BOUNDARY MONUMENT LEGEND

Lot 21, BIRCH GROVE ON GULL, Section 9, Township 134 North, Range 29 West, Cass County, Minnesota, EXCEPT that part of said Lot 21 described as follows:

Beginning at the Northwest corner of said Lot 21; thence Southeasterly along the southwesterly line of said Lot 21, a distance of 50.00 feet; thence in a northeasterly direction parallel to the south line of Oak Drive as platted in BIRCH GROVE ON GULL, for a distance of 4.00 feet; thence Northerly parallel to the southwesterly line of said Lot 21, a distance of 50.00 feet to the intersection with the south line of said Oak Drive; thence Southwesterly along said Oak Drive to the Northwest corner of said Lot 21.

AND

That part of Government Lot 4, Section 9, Township 134 North, Range 29 West, Cass County, Minnesota, described as follows:

Beginning at the most easterly corner of said Lot 21, BIRCH GROVE ON GULL; thence South 55 degrees 10 minutes 51 seconds West, along the southeasterly line of said plat BIRCH GROVE ON GULL, a distance of 200.31 feet to the southwest corner of Lot 22 of said plat BIRCH GROVE ON GULL; thence South 34 degrees 55 minutes 09 seconds East, along Document Number 440865, a distance of 234.96 feet; thence North 05 degrees 34 minutes 17 seconds East, a distance of 308.49 feet to the point of beginning.
