

That part of OUTLOT A, SOUTH WINNIE HIDDEN HARBOR, according to the recorded plat thereof, Cass County, Minnesota described as follows: BEGINNING at the easterly most corner of Lot 13, Block 1, said plat of SOUTH WINNIE HIDDEN HARBOR; thence South 56 degrees 18 minutes 58 seconds West, assigned bearing, along the southeasterly line of said Lot 13, a distance of 109.84 feet to the southerly most corner of said Lot 13; thence North 88 degrees 43 minutes 38 seconds East 82.74 feet to the east line of said OUTLOT A; thence North 01 degrees 17 minutes 08 seconds West, along said east line, 58.87 feet to the point of beginning. SUBJECT tract is non-compliant on it's own and must be attached to an adjoining tract.




