



William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 10th day of September, 1963, I found the section corner of sections 29-30-31-32 which was evidenced by Field notes for county ditch #11 Survey by County Engineer, C. J. White in 1921. Notes filed in County Engineer's Office.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter galvanized steel Monument 60" long
