





, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 20th day of August, 1963, I found the Section corner of Sections 25-26-35-36 which was evidenced by remains of a survey by County Surveyor, James H. Flynn in 1921 which consists of a 3/4" x 30" Iron Monument with square head.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" Cylindrical 24" long Concrete Monument Capped with a 3" diameter bronze tablet set 6" below surface of road stamped:
