








## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 16th day of December, 1955, I found the Quarter corner of Sections 21 - 22 which was evidenced by remains of the G.L.O. resurvey of 1918 consisting of 1 inch diameter iron post, 3 feet long with brass cap marked:

Poplar 6 inch N35°E 29.04 feet - now rotted stub.

Poplar 7 inch N68°W 9.90 feet - not found.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. monument is in good condition.

from which reference or witness monuments are located in the manner following:

Ash 7 inch S19°W 24.4 feet scribed ¼ S21 BT

Steel sign post 72 inches due south 8.3 feet with Forest Service signs 54-2 and 54-4 attached.
