

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 5th day of September, 1969, I found the meander corner of Sections 7-18 which was evidenced by remains of the G.L.O. resurvey of 1919 consisting of
W. Pine 12 inch N8°E 54.12 feet - found 27 inch scribe overgrown at record bearing and distance
W. Oak 10 inch S37°15'W 27.72 feet - found 20 inch scribe overgrown at record bearing and distance

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 6 inch diameter concrete monument 24 inches long capped with a 3 inch diameter brass tablet marked

T.141N. R.27W.
