

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minn., and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 20th day of January, 1964, I found the Southeast 1/16 corner of Section 16 which was evidenced by the remains of the General Land Office Survey of 1918. A 1 inch iron post with brass cap stamped: SE 1/16 S 16 was found to be marking corner. One bearing tree - 1918 Red Pine 5" N39°W 27 links or 17.82 feet (Now a 1 1/4 inch red pine at record bearing and distance).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument was set as the brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

GLO Red Pine 1 1/4" N39°W 17.82 feet rescribed "BT".
