

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 15th day of February, 1963, I found the Quarter corner of Sections 17 - 18 which was evidenced by the remains of the C.L.C. reurvey of 1918.

Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:-
 Alongside of corner is a 1 1/4 inch diameter iron pipe.

Maple 10 inch S60°45'E 60 links (39.6') (Now a decayed stump at record bearing and distance.)

Maple 8 inch S81°W 71 links (46.86') (Now a stump hole S81°W 46.86 feet.)
