

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 18th day of June, 1965, I found the North Closing corner of sections 27 and 28 which was evidenced by the remains of the G.L.O. resurvey of 1918. Corner marked by

a 1 inch diameter iron post with brass cap marked
