

I further depose and say that on the 8th ..... day of August ..... , 1968, I found the Angle Point ..... corner of Section 12 ..... which was evidenced by remains of the G.L.O. resurvey of 1917 consisting of 1 inch diameter iron post 3 feet long with brass cap marked.
