

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 8th day of August, 1965, I found the standard section corner of sections 36 - 31 which was evidenced by remains of original Government survey of 1873.

Pine 22 inch N33°W 16.50 feet - now a burned stump at record bearing and distance.

Also remains of a 2 inch diameter capped iron pipe, which was placed there by the County.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter, 5 feet long galvanized steel pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped.
