



William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 30th day of November, 1964, I found the Section corner of Section's 9-10-15-16 which was evidenced by remains of G.L.O. resurvey of 1917.
1 inch diameter iron post 3 feet long set flush with ground.

Poplar 6 inch N22 $\frac{1}{2}$ ⁰E 110.22 feet - not found.
 Y. Pine 8 inch S67 $\frac{1}{2}$ ⁰E 96.36 feet - now a pine stump.
 Y. Pine 10 inch S21 $\frac{1}{2}$ ⁰W 182.16 feet - now a pine stump.
 Y. Pine 8 inch N21⁰W 75.24 feet - not found.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new marker set, old one's in good condition.
