

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 26th day of June, 1962, I found the Quarter corner of Sections 17 - 18 which was evidenced by remains of a survey by John Curo, Cass County Surveyor in 1915.

Iron monument (found a 1 1/2" inside diameter iron pipe marking corner)
 Found 2 local bearing trees with scribing plain. Scribe approximately 25 years old.
 Jack pine 11" N55°E, 30.0'
 Jack pine 12" S77°W, 17.8'

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 5' long galvanized wrought iron pipe filled with concrete and capped with a 3" diameter bronze tablet stamped:-
