

, being first duly sworn, deposes and says:
That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 24th day of April, 1962, I found the Center East 1/16 corner of Section 26 which was evidenced by a survey of Cass County Surveyor E. P. Horst in 1920 recorded in Cass County record book "C" page 462.

Iron monument (found a 2 inch outside diameter iron pipe marking corner).
Location checks with timber type map and aerial photos.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter 5 foot long cylindrical concrete monument capped with a 3 inch diameter bronze tablet stamped:-
