







, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 25th day of May, 1962, I found the East 1/16 corner of Sections 30-31 which was evidenced by Notes of Cass County Surveyor E. B. Horst found in County Record Book "C" page 446.

Iron Monument (found a 1 3/4" inside diameter iron pipe marking corner)

(Pipe was alongside a fence corner estimated to be 30 years old).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter 5' Long cylindrical concrete monument capped with a 3" diameter
